Consideration of the 2019-2020 proposed Preliminary Budget. The budget for Kern LAFCo is determined by the Commission and funded by the County of Kern, the Incorporated Cities in Kern County, and the Independent Special Districts that Kern LAFCo is designated as the Principal County. 6. PUBLIC PROJECT REVIEW:

a. 1746 CITY OF MCFARLAND: Annexation No. 17<u>Vote Required</u>

The proposed annexation area contains a total of 79.99 acres and comprises 3 parcels; (1) APN 060-090-29, is 74.44-acre parcel. (2) APN 060-090-08 is 1.25-acre parcel. (3) APN 060-090-30 is 4.3-acre parcel. All three parcels are contained in a rectangular land area situated at the southwest corner of the intersection of Taylor and Garzoli Avenue which is in the southwest quadrant of the McFarland community. The land is currently used for agriculture with the possibility of future residential. The surrounding properties include agriculture, rural residential and a Junior High School.

This proposal has 100% landowner consent and the applicant has requested that notice hearing and protest hearing be waived. (**Resolution**)
